Pursuant to Circular No. 96/2020/TT-BTC dated 16 November 2020, issued by the Ministry of Finance, and regulations by the Hanoi Stock Exchange regarding information disclosure in the stock market, the post-tax profit difference for Q1 2025 compared to the same period of the Vinacomin - Ha Lam Coal Joint Stock Company is as follows:

The Post-Tax profit of the Company in Q1 2025 decreased by VND 6,297,158,966 compared to Q1 2024. The main reason for this decline was due to difficult geological conditions and instability in certain mining areas. Several mining faces encountered hard rock layers, which slowed down the mining progress, reduced coal output and increased the ash content of the raw coal extracted in Q1 2025.
